Standard text license:

The EMVA 1288 Standard text itself is licensed to all under the terms of the Creative Commons 4.0 BY-ND license (<https://creativecommons.org/licenses/by-nd/4.0/>).

Compliant Logo license:

Any company or institution can obtain a license, free of charge, to use the 'EMVA 1288 Standard Compliant' logo set out here in relation to datasheets and sensor/camera specifications and other products (including software implementations, as the case may be), provided that these are measured and conformant with the standard. The license terms are as follows:

1. To use the logo, licensee data or products must conform to the relevant release of the EMVA 1288 Standard. Licensees will self-certify conformance of their measurement setup, computation and representation of the datasheet with which the 'EMVA 1288 Standard Compliant' logo is used. Licensees have to check regularly their conformance with the relevant release of EMVA 1288 Standard.
2. The licensee agrees that if it does hold or plans to hold intellectual property rights the use of which would be required for conformance with the current EMVA 1288 Standard and does not declare them, the logo license applicant automatically grants a RF-FRAND (Royalty-Free-, Fair, Reasonable and Non-Discriminatory) sublicensable license to use, make, have made, commercialize, sell, import, export, reproduce, transform, distribute or otherwise exploit the subject of the intellectual property rights to the EMVA and any and all EMVA 1288 Standard Group members and Standard licensees under the terms of the license chosen by the Working Group and EMVA solely for the publication, distribution and exploitation of the Standard and any Reference Implementation without any patent right exclusion clause.¹
3. If a licensee publishes data, sensor/camera specifications and other products claimed to be EMVA 1288 Standard compliant or provides them to a customer or any third-party, it also has to provide the full datasheet². An EMVA 1288 compliant datasheet must contain all mandatory measurements and graphs (Table 1 in Section 4.4.2) and the standardized EMVA 1288 summary datasheet (see Section 10.2).
4. Licensee agrees not to hold EMVA liable for any data or products released by it under or associated with the 'EMVA 1288 Standard Compliant' logo nor any damage or loss resulting from their publication, commercialization, sale or distribution or any other use, and will hold EMVA harmless of any such claims brought by third parties in respect of the same.
5. Licensee agrees that the name of his organization is published at the EMVA website as licensee of the EMVA 1288 Standard compliant logo.
5. EMVA retains the right to withdraw the granted license if a licensee violates any of these license conditions.
